A SEASONAL BURN MORATORIUM ON RESIDENTIAL BURNING SHALL BE IMPOSED ANNUALLY, JUNE 15 THROUGH SEPTEMBER 30 - WHICH MAY BE EXTENDED.

This permit is issued on the following terms, conditions and proposed purposes stated herein:

Required conditions of RESIDENTIAL / YARD WASTE burning:

- Permitted year round, only in rural areas (except during the moratorium or a burn ban).
- To determine if you reside in a rural area (outside the urban growth area), go to the [King County GIS website](#) and follow these instructions: enter your address, look under the KC Planning & Critical Areas Designations section. This will tell you if your home is in a rural or urban growth area.
- Only natural vegetation shall be burned.
- Only one pile shall be burned at a time, 10:00 am – sunset.
- There shall be no residential burning within 50 feet (100 feet in diameter) of any fences, trees, structures, or other combustible materials.
- The fire shall be no larger than 4 feet (in diameter) by 3 feet (in height), consisting of leaves, clippings, pruning, and other yard and garden refuse only. The material being burned must originate on that property. Burn barrels are prohibited.

Required conditions of COOKING / RECREATIONAL CAMPFIRES:

- Permitted year round (in both urban & rural growth areas), except during a burn ban.
- This fire shall be no larger than 3 feet (in diameter) by 2 feet (in height).
- It shall consist of charcoal, dry seasoned firewood, or manufactured fire logs (no debris or yard waste), used for cooking or campfires.
- No cooking/recreational burning within 25 feet of structures, fences, trees, or other combustibles.

Additional required conditions for ALL OUTDOOR BURNING:

- Burn permit shall be at the site while burning.
- Personnel and equipment, capable of extinguishing the fire, shall be always on site while burning (equipment examples: charged garden hose, fire extinguishers or several 5-gallon buckets of water).
- Smoke emitted from any burning shall not cause impact to another person or property. This permit may be revoked at any time, based on any type of complaint received without on-site verification by Eastside Fire & Rescue. If smoke from your fire bothers your neighbors, damages their property, or otherwise causes a nuisance, you must immediately put it out.

- All fires are prohibited during air-quality burn bans and fire-safety burn bans. Check the link below for intermittent air quality related burn bans, imposed by [Puget Sound Clean Air](#) (800-595-4341) and fire safety burn bans at [Eastside Fire & Rescue](#).
